CONSIDER APPROVAL OF THE FIRST AMENDMENT OF THE MEMORANDUM OF UNDERSTANDING BETWEEN ARVIN-EDISON WATER STORAGE DISTRICT AND ARVIN COMMUNITY SERVICES DISTRICT FOR IMPLEMENTATION OF THE SUSTAINABLE GROUNDWATER MANAGEMENT ACT WITH ARVIN-EDISON WATER STORAGE DISTRICT

CONSIDER APPROVAL OF MEMORANDUM OF AGREEMENT BETWEEN ARVIN COMMUNITY SERVICES DISTRICT, ARVIN-EDISON WATER STORAGE DISTRICT, TEJON-CASTAC WATER DISTRICT, AND WHEELER-RIDGE WATER STORAGE DISTRICT FOR SOUTH OF THE KERN RIVER GROUNDWATER SUSTAINABILITY PLAN

Mr. Muhar presented the <u>First Amendment</u> of the <u>Memorandum Of Understanding</u> and noted the amendment was necessary to address the transition from Kern Groundwater Authority GSP into the South of Kern River GSP, and staff is recommending the Board of Directors approve the amendment.

Mr. Muhar then presented the <u>Memorandum of Agreement</u> (MOA) and noted the MOA provides for governance as well as the roles and responsibilities for the four (4) agencies, and the vehicle for submitting a joint South of the Kern River Groundwater Sustainability Plan (GSP) to the Department of Water Resources along with the other five (5) GSP's in the Kern Subbasin.

Mr. Muhar finally noted the Arvin GSA, which includes the Arvin Community Services District boundary, and in coordination with Wheeler Ridge-Maricopa GSA and Tejon Castac Water District GSA, has completed the process of transitioning its Kern Groundwater Authority Management Area Plans into a South of the Kern River (SOKR) GSP as well as addressing the deficiencies highlighted by DWR.

Following a long discussion, Director Yurosek motioned, seconded by Director Johnston, and unanimously voted to (1) approve the First Amendment of the Memorandum of Understanding between Arvin-Edison Water Storage District and Arvin Community Services District, (2) approve the MOA, and (3) approve the Draft South of Kern River Groundwater Sustainability Plan for Public Comment:

REPORT ITEMS

FRIANT DIVISION AND FRIANT WATER AUTHORITY (FWA) Friant-Kern Canal Subsidence (FKC)

Mr. Muhar provided an update on the information in the Board packet regarding the FKC construction including reports on cash flow activities with substantial completion of the project anticipated in January 2024.

Friant-Kern Water Quality

Mr. Muhar provided an update on the information in the Board packet stating the Ad-Hoc Committee is working on the Water Quality Guidelines as well as the voluntary "Cooperative Agreement" which will ultimately provide the FWA authority to implement such a program on USBR owned facilities.

Miscellaneous

Mr. Muhar provided an update on the information in the Board packet noting; Class I declaration is still standing at 15%, but could increase to 30% if the San Joaquin River Exchange Contractor deliveries are switched to Delta-Mendota Canal by end of June or early July; San Luis Delta Mendota Water Authority issues are Electrical Transmission Project Agreements and cost accounting of SJR water releases address flood type only; Blueprint continues to make progress and adopted a Strategic Plan; FWA External Affairs report in the Correspondence portion of the Agenda; as well as several closed session topics to be discussed.

AGENCY/AUTHORITY/COMMITTEE REPORTS

Kern Groundwater Authority (KGA)

Director Yurosek and Mr. Muhar attended the KGA Board of Directors' meeting held on May 25, 2022 as well as various other coordination calls/meetings regarding the DWR comment letter as outlined in the Board packet.

South of Kern River Amended Groundwater Sustainability Plan (GSP) Update

Mr. Muhar highlighted the action items related to Arvin's joint development of an amended GSP for management areas of the South of Kern River with Wheeler Ridge-Maricopa Water Storage District, Tejon-Castac Water District and Arvin Community Services District (collectively, SOKR) as outlined in the Board packet and noted the clarification letter to Kern Groundwater Authority and the GSP timeline.

White Wolf Groundwater Sustainability Agency

Director Giumarra and staff attended the Board of Directors' meeting on June 7, 2022 and noted the technical presentation in their Board Packets, which provides for additional details and a summary of ongoing matters.

Mr. Muhar reviewed year-to-date delivery summary, in-district demand, wellfields, groundwater and surface supplies for the year, groundwater level information and recent rainfall/snowpack info.

Water Supply and Prorate Update

Mr. Nixon provided an update on the 2022 Water Year Prorate Program schedules and noted the second landowner turnback pool would need to be communicated to Landowners prior to the next board meeting and requested approval of a \$300 per acre-foot price. Director Fanucchi motioned,
